

North County Detention Facility - Visitor Information and Guidelines

Inmates Are Entitled To A One Hour Visit Per Week

Non-Contact Visiting for Units 101, 201, 301, 501, 502

Sign up **15 minutes** prior to the start of visiting

Saturday or Sunday 12:30 – 1:30 PM; 2:00 – 3:00 PM

Non-Contact Visiting for Units 202, 203, 401

Sign up **30 minutes** prior to the start of visiting

Saturday or Sunday 8:00, 9:00, or 10:00 a.m.; 6:00, 7:00, 8:00 or 9:00 p.m.

Monday, Tuesday, Wednesday or Thursday 5:30, 6:30, 7:30, 8:30 or 9:30 p.m.

Attire

- Shorts, skirts, and dresses must be as long as the bottom of your fingertips when arms are placed at your side
- No bare midriffs, low-cut tube tops, or revealing tops
- No tank tops
- No sports team attire or gang insignias
- No bandanas, beanies, hairnets, or hats
- No steel-toed boots

If you are unsure about your attire's acceptability, you want to dress as if you were going to court. Final determination of clothing will be made by Lobby staff.

General Information – Inmates housed at the NCDF are allowed one, 1-hour visit per week. In non-contact visiting for 101, 201, 301 and 501/02, the inmate's visitors may only fill three seats. Small children (40 inches or smaller) must be held on a visitor's lap. Children over 40 inches must occupy a seat and will be counted as a visitor. In non-contact visiting for 202, 203 and 401, only three visitors may occupy a booth. Rules regarding children for non-contact visiting in these areas are the same as stated above.

All visitors 18 years and older, must have a valid and current California Drivers License, California Identification Card, Drivers License/ID from another state, Passport, Military Identification or Immigration Card. Employee ID cards presented along with a temporary Driver's License will also be accepted. No other forms of identification will be accepted. Minors (age 17 and under) must be accompanied at all times by an adult. Children must be supervised by an adult at all times and **may not** be left unattended in the lobby.

Convicted felons who wish to visit must have prior written approval from the Facility Manager or their designee.

If you are a recently released inmate of the Detention Division, you must wait 30 days from the day of your release before returning to visit unless you are visiting your spouse.

Unacceptable Behavior: There will be **NO** physical contact allowed at any time before, during, or at the end of visiting.

Items Allowed - Locker key, visitor's pass, eyeglasses, inhaler, baby-bottle, if necessary. Any emergency items must be approved by custody staff.

Items Not Allowed - Weapons of any kind, cigarettes, lighters, keys, knives, pagers, cellular phones, hats, excessive jewelry and toys.

Visitors are required to secure all of their property in the lockers provided in the lobby or in their vehicles.

Any person who appears to be under the influence of alcohol or any controlled substances will not be allowed to visit.
